## B-Conditions:

Title/Application: Qeshm Airlines OW/RT Economy class fares applicable to all tickets issued on/after 01DEC 2013 for travel on/after 01DEC2013.

**1-Eligibility:** No requirement.

**2-Minimum Stay:** No requirement

**3- Maximum Stay:** As mentioned in the fare table

**4-Permitted combination:**

A-End-on-end combination with Qeshm Air domestic sector is permitted. Example:

MHD-THR-NJF-THR-MHD

B-Local combination based on half RT is permitted provided that more restrictions shall apply to the whole journey. Example: Maximum validity of ticket issued on the following route will be 14 days no matter inbound portion is on Y/class:

**5-Sales Restrictions:** Ticket must be issued on Qeshm Air ticket stock. Issuing SOTO tickets are permitted by converting applicable BSR.

**6-Rebooking:**

For Y/V/M: IRR 500000 in Iran and USD 15 in Iraq.

For C/class: IRR 700000 IN Iran and USD 20 in Iraq

Note: There is no rebooking charge (CRCN) for domestic sector when domestic and the above fares are combined and issued in single or conjunct tickets.

**7-Child and Infant Fares:** Charge 75% and 10% of adult fares respectively

**8-Free Baggage Allowance:** 40 Kg for Business and 30 Kg for Economy.

**9-Upgrading:** Difference of applicable fares shall be collected

**10-Refund:**

A-For partially used tickets: Deduct applicable OW fares. In case of MEE14D: Deduct V/class OW

B-For totally unused tickets: IRR 800000

**11-Ticket Endorsement:** Please show the following phrases in the tickets:

For Y/V/M: "Rebooking charge IRR 500000 and Refund IRR 800000

For C/class: Rebooking charge IRR 700000 and Refund fee IRR 800000.

**12-Taxes, Fees, Charges:** Applicable taxes of Iran and Iraq shall be collected and shown in the tickets.

**13-Form of Payment:** Cash+QMF92/111
