B-Conditions:

Title/Application: Qeshm Airlines OW/RT/OJ Business and Economy class fares applicable to all tickets issued on/after 21APR14 for travel on/after 21APR2014.

1-Eligibility: No requirement.

2-Minimum Stay: No requirement

3- Maximum Stay: As mentioned in the fare table

4-Permitted combination:

A-End-on-end combination with Qeshm Air domestic sector is permitted. Example:

THR-GSM-DXB

B-Local combination based on half RT is permitted provided that more restrictions shall apply to the whole journey. Example: Maximum validity of ticket issued on the following route will be 06 days no matter inbound portion is on Y/class:

GSM M/class-DXB Y/class GSM

5-Sales Restrictions: Ticket must be issued on Qeshm Air ticket stock. Issuing SOTO tickets are permitted by converting applicable BSR.



6-Rebooking (Change of Reservation):

a) When rebooking takes place in Iran: IRR 500000

b) When rebooking takes place in Emirates: AED 50

Note: There is no rebooking charge (CRCN) for domestic sector when domestic and the above fares are combined and issued in single or conjunct tickets.

7-Child and Infant Fares: Charge 75% and 10% of adult fares respectively

8-Free Baggage Allowance: 30 Kg for Business and 20 for Economy.

9-Ugrading: Difference of applicable fares shall be collected

10-Refund:

a-for partially used tickets: Deduct applicable OW fares. In case of MEE06d: Deduct V/class OW

b-For totally unused tickets: IRR 700000 FOR Y/V/M classes and IRR 900000 for C/class

12-Ticket Endorsement: Please show the following phrases in the tickets:

For Y/V/M: Rebooking charge IRR500000 and Refund fee IRR 700000

For C/class: Rebooking charge IRR 500000 and Refund fee IRR 900000

13-Taxes, Fees, Charges: Applicable taxes of Iran and Emirates shall be collected and shown in the tickets.

14-Form of Payment: Cash+QMF93/101
