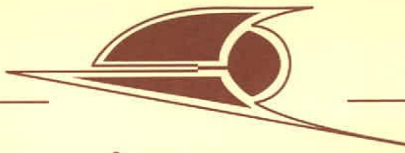

7-REFUND:

For C/class:

Before Commencement of travel: Charge IRR 1200000 for tickets issued in IRR and AED 120 for tickets issued in AED.

After commencement of travel: Deduct OW+IRR 1200000 for tickets issued in IRR and OW+AED 120 for tickets issued in AED

For V/class and M/class:

Before Commencement of Travel: Charge IRR 1000000 for tickets issued in IRR and AED100 for tickets issued in AED.

After commencement of travel: Deduct OW+IRR 1000000 for tickets issued in IRR and OW+AED 100 for tickets issued in AED

9-Child and INF Fares: Charge 75% and 10% of fares respectively

10-Free Baggage Allowance: 40KG for business and 30KG for Economy
