**Dear Valued Partner,**

Effective 13 August 2020, all passengers departing on QR operated flights from **Iran, Bangladesh, Brazil, Iraq, Pakistan, Philippines and Sri Lanka** shall provide a negative COVID-19 RT-PCR test

- Test result shall be issued **within 96 hours** prior to flight departure from one of the authorized laboratories. The list of **Iran** approved laboratories is as below:

### Exemptions:

- a. Children under 12 years are exempted if travelling with their family who are holding a negative test.
- b. Infants are also exempted from PCR test requirements.
- Children under 12 years travelling as UM (unaccompanied minor) are not exempted and must hold certificate of proof from the authorized medical center.
- Passengers must possess two copies of the test result, must fill and submit a consent form along with the RT-PCR test result. Form is available at:

- If passengers are unable to provide the negative test result and consent form at check-in, **they will not be accepted for boarding the flight**. These requirements apply to both existing and new bookings
- **Cost** for the test shall be absorbed by passenger
- If passenger is returning **within 48 hours** from arrival to the country, another test is not required by Qatar Airways, but if the final destination has a governmental requirement, the new test is still mandatory

**The Passenger Guidelines – Travel With Confidence 1059 Policy** also applies to passengers holding tickets issued on Qatar Airways (157) stock or plate booked on QR and/or OAL flights:

- To/from/via any point which is declared as operating, however, passenger was tested positive on COVID-19 is considered as involuntary changes.
- To/from/via any point which is declared as operating, however, passenger refused to undergo RT-PCR test on COVID-19, or failed/refused to present report with a negative COVID-19 RT-PCR test result as required by Qatar Airways or government regulation is considered as voluntary changes.
- For ticket exchange/reissue **must** update: **“INVOL COVID COMM1059 DUE PCR”** at the beginning of the Endorsements Box and **“I” indicator** at the beginning of the fare construction, however, **“voluntary” Travel with Confidence (TWC) options** and conditions specified in this Guidelines applies to passengers who failed or refused to present a negative test report, as well as to those who refused to undergo a test



- Negative covid-19 RT-PCR test will also be required from passengers travelling on QR operated flights from **Armenia, India, Nepal, Nigeria and Russia**, when QR resumes own services from these countries, and is also required for any existing special/charter flight operation

**Passenger travelling to/from/via any destination, however, at departure date they are positive on COVID-19**

- Passenger who opts to rebook shall be advised to wait at least 14 days from the positive test before flying again and shall undergo another RT-PCR test and supply a negative result
- Message “SR OTHS YY – PLS VERIFY PCR TEST” shall be updated in the PNR and negative RT-PCR test verified at the time of ticket reissue. **To ensure data protection compliance, please ensure that no test result and/or medical condition is stored in the PNR**, however, records may be stored by Qatar Airways no longer than **1 year** from last travelled coupon issued on the ticket
- Passengers need to take the RT-PCR test if they are **transiting from a domestic flight** in countries specified above, as well as if they are **travelling or connecting** on a Qatar Airways flight **from a country** where Qatar Airways or governmental regulation **requires** the RT-PCR test
- Passengers travelling on OAL feeder flights from countries where QR does not have approved laboratories, may present a negative RT-PCR test result. Test shall be issued by any laboratory in the country of embarkation on laboratory headed paper.

Example:

SCL BB X/GRU QR X/DOH QR IKA

Passenger can present a test on headed paper from any laboratory in Chile

- For ticket exchange/reissue **must** update: **“INVOL COVID COMM1059 DUE PCR”** at the beginning of the Endorsements Box and **“I” indicator** at the beginning of the fare construction
- **“Involuntary” options** and conditions specified in this Guidelines applies to passengers who at departure date are positive on COVID-19
