01. Travel validity:	01 April 2016 until further notice.
02. Seasonality:	None.
03. Endorsement box:	NO ENDORS.
04. Discounts:	CHD (over 2 and under 12 years) 25% of applicable adult fare. INF 90% of applicable adult fare.
05. Unaccompanied Minor (5-12 years):	100% of applicable adult fare.
06. Baggage allowance:	Economy class 30kg. Business class 40kg. INF 10kg. Hand baggage 5kg. Maximum weight of each baggage should not exceed 32kg.
07. Open Jaw:	Permitted to all W5 points provided the roundtrip fares of origin are combined on 1/2 RT basis.
08. Rebooking:	Date change permitted free of charge, Except XIT45D:EUR50 , LIT1M & NIT14D:EUR100 per each segment based on ratified rate. In case of increasing FARE & TAX amount, difference shall be paid. No-show tickets will be rebooked at charge of No-show fee.
09. Extension of ticket validity:	Permitted, respective fare difference to be collected. (Add Rebooking fee when applicable)
10. Refund and No-show fee: (Amounts as shown above)	For partially used tickets deduct applicable listed one way fare and refund balance. (Add No-show fee when applicable) No-show fee applies to outbound and inbound travel. When unused ticket of a No-show passenger is presented for refund, only No-show fee should be collected.
11. Iran domestic flights:	50% discount on W5 domestic fare is permitted in continuation of DUS/MUC-IKA v.v. ticket.
12. Taxes and fees:	Not included.
13. Mixed class:	Permitted. (Validity of lower fare applies to the entire journey)
