These guidelines have been published for confirmed 157 tickets on QR operating or code-share flights to/from Iran, Iraq, Jordan and Lebanon which are impacted by schedule change (flight cancellation, misconnection or retiming more than two hours):

Rebooking/Rerouting	<ul> <li>Two free reissues permitted on QR operated flights to/from</li> <li>Armenia/Azerbaijan/Bahrain/Cyprus/Egypt/Georgia/Iran/Iraq/Jordan/Kuwait/Lebanon/Oman/Qatar/Saudi</li> <li>Arabia/Turkey/UAE for travel: <ul> <li>on/before 14 December 2024 in the lowest available RBD</li> <li>on/after 15 December 2024 and on/before 15 January 2025 in the same RBD as original, or if not available, up to next three higher RBDs</li> <li>on/after 16 January 2025 and on/before 31 January 2025 in the lowest available RBD</li> </ul> </li> <li>May include feeder on the operating flight of the same OAL (except of LH) and gateway into the OAL RBD permitted according to ticketed Fare Basis:</li> </ul>
